In accordance with the Unemployment Security Act all those who are obliged to take out YEL or MYEL insurance and those who own shares in the company they work for (own ownership at least 15 % or at least 30 % between family members) and work in a leadership position in the said company, as well as the entrepreneur's family members who work in the family firm and reside in the same household (own or family members' combined share of ownership at least 50 %), are considered entrepreneurs.
